- Historic Substance Misuse
- Traumatic Histories
- Significant Previous Management Problems
- Contact with Criminal Justice System

2. A summary breakdown of which services the patients were referred to with particular reference to the following:

- a) Another NHS Rehabilitation Facility
- b) Independent Sector Facility
- c) Supported Living Scheme
- d) Other Community Service

Please could you include the name and geographical location of the service referred too?

3. A further breakdown of the number of Out of Area Placements made between January 2017 and January 2020 of patients with the same admission characteristics as those detailed in Question 1 with particular reference to the following:

- a) The name and geographical location of the service referred too?
- b) What was the total cost of out of area placements to the Trust from January 2017 to January 2020?

**OUR RESPONSE:** From our preliminary assessment, we estimate that compliance with your request would exceed the appropriate costs limit under section 12 of the Freedom of information Act 2000, currently £450, as we do not centrally record some of the information being requested at 1 above and would need to check every patient's record to locate and retrieve the information. However, rather than refusing your request in its entirety we are providing information where it is reasonable to do so.
