Chief Executive's report

Purpose of the Report

This paper provides an update on current local issues and national policy developments since the last meeting. The details below are drawn from a variety of sources, including local meetings and information published by NHS England, NHS Providers, the NHS Confederation, and the Care Quality Commission (CQC).

Analysis of the Issue

National Developments

Consultant and Junior Doctor Strike Action

Consultants begin their strike action on Tuesday (19 Sept) and are joined by junior doctors on Wednesday (20 Sept). On Wednesday from 7am, both junior doctors and consultants will deliver Christmas day levels of staffing only, meaning that while emergency care will be provided. Both groups will then strike on 2, 3 and 4 October, again providing Christmas day cover.

Covid Vaccinations

People at greatest risk of serious illness from COVID-19, including care home residents, over 65s and frontline health and social care workers, are eligible for an autumn vaccine booster.

The autumn covid vaccination is available from 18 September for those who are eligible. Adult who are eligible for winter vaccines, including all aged 65 and over, pregnant women and those with an underlying health condition will begin receiving invitations from the NHS to encourage them to get their covid and flu jabs from this week. A covid vaccination for those aged under 18 years will begin later in the year.

Annual Childrens Flu Vaccinations

The annual NHS <u>flu vaccination programme for children</u> aged 2 to 3 years, school age children and children over 6 months with certain health conditions is getting underway from this month. children in reception to year 11 will be offered the free nasal spray flu vaccine, delivered in schools by immunisation teams. Children aged 2 and 3 years (on or before 31 August) are eligible for the free nasal spray via their GP practice.

Children aged between 6 months and 2 years with a long-term health condition that makes them at higher risk from flu will be offered a flu vaccine injection instead of the nasal spray. This is because the nasal spray is not licensed for children aged under 2 years.

Lucy Letby Statutory Inquiry

Earlier this month, the Health and Social Care Secretary Steve Barclay gave an update to the House of Commons on the Lucy Letby Case. Letby was convicted of the murder of 7 babies and the attempted murders of 6 others. Crimes

she committed while working as a neonatal nurse at the Countess of Chester Hospital between June 2015 and June 2016. Steve Barclay confirmed that an independent inquiry has been ordered to investigate the events at the Countess of Chester Hospital, making clear the victims' families would shape this, and stated that they were "committed to putting in place robust safeguards to protect patient safety, and to make sure the lessons from this horrendous case are fully learned".

SIREN study

The UK Health Security Agency's study 'SIREN' is moving into its next phase during September 2023. The SARS-CoV-2 immunity and reinfection (SIREN) study has continually tested healthcare workers across the UK for COVID-19, providing information relating to the virus. The evidence it has collected on immunity, vaccination and emerging variants played a critical role in informing the national response. The work aimed at continuing to gather an understanding of the impact of these viruses on winter pressures in healthcare in winter 2022 will continue this year.

Winter Resilience

The Government is investing £200 million funding to boost NHS resilience this Winter to ensure that patients receive the care they need. Winter is the busiest time for the NHS, with increased pressures from flu, COVID-19 and seasonal illness - combined this year with ongoing pressure from industrial action. That's why the government has started planning earlier than ever before to ensure patients get the care they need.

NHS Capacity

As part of the NHS urgent and emergency care recovery plan published in January this year, £250 million of government funding has been allocated to NHS hospitals to increase capacity, this includes the creation of additional beds to treat patients more quickly and cut waiting lists. It will also support the increase of capacity though the winter period.

Thirty NHS organisations across England will benefit from the investment in urgent and emergency care services, including an allocation of funding for University Hospitals of Leicester NHS Trust.

Strategy to reduce suicide

A new national strategy aimed at reducing the number of suicides has been outlined by the Government, with the aim of reducing England's suicide rate within 2 and a half years (at the latest) with the launch of a new national suicide prevention strategy, this include the targeting of specific groups in our communities who are most at risk of suicide including children and young people, middle-aged men, autistic people, pregnant women and new mothers.

This strategy is part of a number of wider measures, including a national alert system, guidance for first responders, real-time surveillance of trends in suicide, and an ambition to grow the mental health workforce (see the <u>NHS Long</u> <u>Term Workforce Plan</u> for more detail).

Suicide Prevention Fund for Charity Sector

A fund has been made available by the Government for the charity sector to work along side the NHS is tackling suicide. Tens of thousands of people experiencing suicidal thoughts or approaching a mental health crisis will receive vital support, as the government relaunches a £10 million fund so charities can work with the NHS to provide life-saving suicide prevention services.

Charities in communities across England can now <u>apply for the latest round of funding from the Suicide Prevention</u> <u>Grant Fund</u> which will ensure as many people as possible can access the support and prevention services they need,

Celebrating Excellence Awards

World Sepsis Day

On Wednesday (13 September), our community hospitals marked World Sepsis Day by sharing a series of information displays. Sepsis accounts for at least 11 million deaths worldwide annually. Early recognition and treatment reduces sepsis mortality by 50%. Lack of knowledge makes sepsis the most preventable cause of death worldwide.

Sepsis arises when the body's response to an infection injures its own tissues and organs. It may lead to shock, multiorgan failure, and death – especially if not recognized early and treated promptly. Sepsis is the final common pathway to death from most infectious diseases worldwide, including viral infections such as Covid-19.

Postdoctoral clinical academic research fellow pharmacist gets published

An LPT postdoctoral clinical academic research fellow pharmacist, Dolly Sud, was the lead author of 'Utilisation of Health Technologies for Physical Health of People with Learning Disabilities: Point of Care Testing' which has recently been published and is open to access for free with support from Aston University.

World Patient Safety Day

The 17 September is World Patient Safety Day. This year the theme is "Engaging patients for patient safety" and the slogan is "Elevate the voice of patients!". The World Health Organisation says: "As users of the healthcare system with first-hand experience of the entire patient journey, the perspectives of patients, families and caregivers are invaluable in improving patient safety.

Tracy Ward, LPT's head of patient safety, said she really welcomes the theme this year. "At LPT we are passionate about ensuring that our patients are really partners in their care and ultimately their safety. We are really clear that to truly achieve high quality and safe care we need to be working together collaboratively and valuing all insights to deliver individualised high-quality care. This year for World Patient Safety Day for the first time we are coming together as an Integrated Care Board and system. This demonstrates LLR's commitment to work together to deliver high quality care for our patients.

Black History Month 2023

October is Black History Month, and this years theme is 'Saluting Our Sisters', dedicated to honouring the achievements of black women. LPT will be having a number of events to commemorate Black History Month, including virtual events, a sponsored walk, and an in-person event hosted by REACH, our Race Equality Staff Network.

Internationally Educated Nurses



A second group of LPT's internationally educated nurses received their competency certificates at a special ceremony at the end of August 2023. They were presented with their OSCE paperwork by Duncan Burton, NHSE's deputy chief nurse and head of international recruitment, at Leicester's City Hall. He also presented the LPT international recruitment team with a certificate recognising the pastoral support given to our recent recruits from overseas.

Mr Burton said he also recognised that supporting international staff to settle into a new country was not a 9-5 job, "Colleagues have gone over and above consistently to provide that support."

Bright Sparks – Making Waves Exhibition

The Bright Sparks Mental Health Annual Open Art Exhibition 'Making Waves' is now on, this is the twenty-second annual exhibition of artworks by mental health service users of Leicester, Leicestershire and Rutland. Asian Professionals National Alliance (APNA) NHS Awards and Conference

APNA is a voluntary organisation made up of NHS health and social care leaders of South Asian descent who come together to share ideas and support each other. APNA established their awards to recognise the contributions of NHS colleagues who are making positive changes, driving inclusivity and supporting our communities and partnerships.

The Trust made the shortlist for the work undertaken as part of the Leicestershire Partnership and Northamptonshire Healthcare Group, for promoting the EDI agenda.
