Chair's Report

Purpose of the Report

This is a regular report for information and accountability, summarising Chair and Non-Executive Director (NED) activities and key events relating to the Well-Led framework for the period April-May. Activities relating to formal Committees of the Board are reported through custom reports.

Analysis of the issue

Fit and Proper Person Test

Significant progress has been made on the required checks for Board members. Chair and Remuneration Committee review and sign off meetings have been scheduled to enable submission by the 27 June deadline.

Chair/NED Appraisals, Recruitment and Succession Planning

NED appraisals will be taking place throughout May and June 2025. The Chair appraisal process is underway in readiness for submission to NHSE by 30 June.

Hetal Parmar has been reappointed as NED and Audit Chair for a further three years from 1 June. We also welcome Melanie Hall to LPT as an Associate NED from 1 May 2025 and NED from 1 June 2025. Melanie is currently a NED at NHFT and will continue in that role during 2025. She replaces Alexander Carpenter whose term ends on 31 May 2025. We take this opportunity to thank Alexander for his positive contribution and support to LPT during his tenure.

Following his successful selection for the Aspirant Chairs programme, Faisal Hussain attended module one of the programme and had the opportunity to engage in various other

developmental activities, including deputising for the Chair at Regional Chairs Briefings and NHS Confed's Mental Health Chairs meetings.

Board Development

We had both an LPT and Joint Board Development Workshop on 29 April. The LPT session provided an opportunity for exploring the current NHS context and medium to long term financial planning. Board members also considered the process for refreshing LPT's Well-Led evidence and reviewed the Board Assurance Framework and the Board's risk appetite for 2025/26.

The joint session provided the opportunity for NHFT and LPT Board members to consider further the Insightful Provider Board self-assessment and receive an update on the CQC State of Care report and its implications for both Trusts. The Boards also discussed the governance and practical arrangements for Group Public Board meetings, including the inaugural meeting planned for 29 May 2025.
